1. Associate Professor: Variable

Remuneration: Negotiable on the basis of Qualification and Experience.

Eligibility:

- i. A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- ii. A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).

A minimum of eight years of experience of teaching and/or research in anacademic/research position equivalent to that of Assistant Professor in a University, Accredited Research Institution/Industry with minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulation 2018.

2. Assistant Professor: Variable

Eligibility

- a. The Ph.D. degree of the candidate has been awarded in a regular mode.
- b. The Ph.D. thesis has been evaluated by at least two external examiners.
- c. An open Ph.D. viva voce of the candidates has been conducted.
- d. The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal.
- e. The candidate has presented at least two papers based on his/her Ph.D. work inconferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or anysimilar agency.
